

INTERNATIONAL COMPETITION APPLICATION APPROVAL FORM

APPROVAL PROCESS

International Competition Application Approval forms must be completed in full and submitted to IPC WDS at ipcwheelchairdancesport@paralympic.org **no later than 3 months** prior to the competition start.

IPC WDS will announce its decision to approve the competition officially in writing.

If approved a **50€** fee must be submitted by the LOC to IPC account and the LOC will be invoiced by IPC WDS.

All approved competitions will appear in the IPC WDS Calendar.

AREA

MINIMUM REQUIREMENTS

Endorsement	If the competition is organized by a different LOC and not by the NPC the application must be endorsed by the respective NPC. The respective field in this application must be filled out.
Rules	The competition will be held according to current IPC WDS Rules available on www.ipc-wheelchairdancesport.org .
Competition Information package	The competition information package draft must be send to IPC WDS for review not later than 4 months prior the start of competition.
Entries	The athlete's final entries must be send to IPC WDS office the day after the final entries deadline and not later than 4-6 weeks prior the start of the competition.
Adjudicators	The competition must be officiated by recognized International Adjudicators (IDSF, WDC, IPC WDS) and the majority of them must have IPC WDS knowledge.
Classification panel	In case that International classification is required the International classification panel(s) (1 or 2 panels, each panel consists of 2 International classifiers) will be appointed by IPC WDS.
Classification process	The International classification schedule will be sent to the respective NPCs after revision of the final entries list. All athletes who will be classified shall bring with them the IPC WDS Medical Information Form in English during classification.
Results	Only results from athletes who have been licensed by IPC WDS (including partners) will be taken into consideration for inclusion in the results and ranking list.
	IDSF results systems or similar to ISDF are recommended to be used. If not, details about the result systems should be provided and approved by IPC WDS.
	The LOC must submit the results from all events to IPC WDS in electronic version no later than 2 weeks after the end of the competition.
